1. It is understood that all Parent/Guardian users of the Parent Connect module of the Detroit Public Schools/Wayne County RESA Student information System recognizes that the information is confidential and only to be accessed by a student's recognized Parent or Guardian.
2. All Parent/Guardians shall use the confidential information that is displayed in the Parent Connect module only for the sole purpose of reviewing student data.
3. All Parent/Guardians have a duty to protect and keep confidential all user IDs and Passwords as well as the information that is accessed in the Parent Connect Module. The Parent or Guardian will use the same degree of care as expected to protect other confidential or personal household information.
4. Parent/Guardians recognize that access to the Parent Connect Module is only given to Parent/Guardians after verification by the Administration of the school that Student attends.
5. Parent/Guardians consent to keep confidential all User ID's and Passwords that provide access to the Parent Connect Module. The User ID and Password will not be shared with Student and/or family members. This is confidential information.
  - a. Lost or Forgotten passwords will only be reset after verification by each individual school that the student of the Parent/Guardian attends.
  - b. If there is more than 1 Parent/Guardian in the household, each Parent/Guardian will have a separate user ID and Password.
6. Information in the Parent Connect Module is for review purposes only. Although efforts are made to maintain and update the information, Detroit Public Schools, Wayne RESA does not guarantee the accuracy of the site. Errors and/or inaccurate information must be addressed directly with the student's school.

This document shall not be construed as creating, conveying, transferring, granting or conferring upon the Parent/Guardian any rights, license or authority in or to the information exchanged, except the limited right to use the Confidential Information in the Parent Connect Module as specified in Statement 2.
